BOARD OF DIRECTOR PETITION

Members wishing to run for a seat on the Priority First Federal Credit Union Board of Directors must file an Official Nomination and Petition Form for nomination. This is a volunteer position. This form can be picked up at any branch office or you can have one sent to you by calling 800-368-0739.

This document must be received by the Board Secretary by **March 18, 2016**. Address: Nominating Committee, Priority First Federal Credit Union, 364 Midway Drive, DuBois, PA 15801. The petition must be signed by 105 members of Priority First Federal Credit Union. Nominations must also include qualifications, biographical data, and a signature validating the nominee's agreement to nomination and willingness to serve if elected. Minimum qualifications for nominees' include:

- Be a member of Priority First Federal Credit Union
- Have or develop the knowledge and experience to perform their duties
- Have no serious derogatory credit history
- Have no convictions for crimes involving personal dishonesty
- Act in the best interest of the Credit Union at all times
- Be prepared to attend all scheduled meetings

Nominations received after the closing date or incomplete nominations shall be disqualified by the Secretary. Elections will not be conducted by ballot and there will be no nominations from the floor at the annual meeting if there is only one nomination for each position to be filled. Election results will be announced at the annual meeting.
